Residual budgets that were not required resulted in an underspend of £0.915m which has been transferred to General Reserve

Redundancies: £1.709m overspend

The cost of redundancies identified and actioned to date through the 2016/17 and 2017/18 MTFP process was £3.709m. This is a significant overspend but shows that savings are going to be made in future budgets as a large number of voluntary redundancies have already been progressed. The overspend of £1.709m has been transferred to General Reserve

Investment Income: £0.505m overspend

Returns on investments were lower than anticipated due to market conditions which resulted in the overspend of £0.505m

Use of Reserves: (-) £0.428m
