## 94 Request for extraordinary meeting - Agenda Item 4

(1) The Chair invited Cllr Liz Leyshon, the Opposition Spokesperson for Resources to set out the request for the Extraordinary Council Meeting to seek debate and assurance being provided to Council. The request said: "Following the financial disclosures around our revenue & reserves, that have come to light during the latest round of saving proposals, our confidence in the Cabinet and their ability to deliver a balanced budget at the end of this financial year has plummeted. We feel that following the decision of Cabinet to implement the saving proposals at today's meeting, a number of important points need to be urgently answered, these being:-

- 1. What contingency plans are in place should these proposed savings fail?
- 2. If no contingency plans are in place, then how can the people of Somerset be assured that this plan is robust?"
- (2) Cllr Leyshon explained the request had been supported by all opposition members. The Deputy Leader of the Council and Cabinet Member for Resources responded and said that the Council had to live within its means and called on councillors to work together for the best interests of Somerset. The Council's Statement of Accounts and Value for Money opinion had been discussed at the July Audit Committee and the feedback from many councillors has been very supportive. Significant savings proposals had been put forward for the September Cabinet meeting and had been agreed, recognising that members had listened to the concerns regarding the proposals for young carers and these had been withdrawn.
- (3) Members were informed that there was a fortnightly robust tracking process in place and there were regular financial update reports at Scrutiny and Cabinet meetings. There was a request for all councillors to get involved and do what they could to help alleviate the funding crisis. All five of the Somerset MPs had been written to regarding the financial difficulties facing the Council and four of them had responded with support.
- (4) There was further debate about opposition councillors being involved in financial discussions at an early stage, the robustness of the savings plan agreed at Cabinet in September, ongoing pressures in Children's Services, the use of capital receipts flexibilities, use of business rates, the scheduled increased frequency in budget reporting to provide assurance and the level of the contingency budget.
- (5) Cllr Rigby indicated his intention to put forward a proposed amendment for the Council to consider. It was agreed to hold an adjournment at 10.36am to allow time for an amendment to be finalised.
- (6) The meeting re-commenced at 10.46am. Cllr Mike Rigby put forward an amendment to the proposal which stated: 'Having heard the Council's contingency plan it is clear that we require a reasonable and robust means of managing our way out of this financial crisis. Council does not agree that the budget set in February 2018 together with the emergency measures agreed in Cabinet on 12 September and the contingencies described today provide that. We therefore call upon Cabinet to provide a costed contingency plan based upon identified risks and also request more regular reporting to Cabinet and Scrutiny meetings.' This was seconded by Cllr Leigh Redman.
- (7) Section 151 officer and Interim Director of Finance, Peter Lewis, said that the proposals put forward at the September meeting were considered robust and that those in-year savings decisions were needed to ensure that the projected overspend was addressed. He provided assurance that SLT meet regularly to review the financial position and that more regular budget monitoring reports are being taken to Cabinet and Scrutiny.

(8) There was a request for a named vote on the amendment proposed by Cllr Rigby and the Council voted 19 for and 30 against, with 1 abstention and therefore the amendment was not carried.
