PQ1	David Redgewell	Taunton Bus Station	From a passenger perspective and an organisation which considers Taunton to be a major transport interchange of the SouthWest, whilst we welcome the new bus rail interchange Taunton Station, we are acutely aware that the design of the interchange being built by Network Rail and First Group only involves 5 bus bays. Therefore, we would be extremely concerned if the Council thought that by shutting Tower Street Bus station that these facilities could be replaced at Taunton Railway Station, without considerable amounts of work and investment in building. We therefore think it is essential that we retain the bus station for its regional connectivity (Wellington, Tiverton, Axminster, Wells and Burnham and Bridgewater), as well as being a major hub for national express.
			 Whilst we wouldn't be against the relocation of the bus station within the town centre and are aware that the Crescent has been previously considered, we would not consider it appropriate to make the Parade into a linear bus Station. The bus station currently includes a café, information centre, staff accommodation and toilets. We would urge the Council to consider full Consultation allowing engagement with Somerset Bus Users, TravelWatch SouthWest, UK Citizens, Transport Focus etc. There must be
			consultation. We must emphasise that, our concern is with retention of facility to the community and not in the land and that if the facility is moved, we would like full consultation with key stakeholders. TravelWatch SouthWest will be supplying it's own note of concern and hope that you will engage with us as soon as possible.

PQ3	Sigurd Reimers	Pensions Investments	 Nearly half of all investments worldwide are made by pensions schemes (1). A large proportion of these investments are in fossil fuels, which are harmful to the climate and the wider environment, and particularly to the younger generation. County Council pensions schemes up and down this country are also involved in making such investments. However, some Councils are already using their ESG (Environmental, Social and Governance) powers in finding attractive alternative investments. Furthermore, Brunel Pensions Partnership, a pensions pool in which Somerset is a stakeholder, have just joined in signing a resolution requesting Barclays Bank to stop investing in fossil fuels. (2) I have attended nearly all the meetings of Somerset County Council's Pensions Committee in the past three years. At most of these I have asked questions about their policy on fossil fuels investments. I have found little, if any, interest in reducing such investments, exemplified in one of their few comments about climate change in their most recent annual report: "For example, the Fund will not require any form of dis-investment from fossil fuels, tobacco or such like." (3) This position is being held despite national resolutions about divestment from large constituent bodies such as some of the Unions (4). Somerset County Council staff contribute to and benefit financially from the Somerset County Council pensions scheme, and are therefore, probably unwittingly, contributing to the problem

PQ5	Mike Ginger	Investment in cycle and walking infrastructure	 Taunton Area Cycling Campaign recently presented our 'Turn the network blue' petition to Councillor Woodman. The petition calls for real investment in cycle and walking infrastructure so that these become alternatives to the 10,000s of short car journeys, particularly with the expected uptake in e bike ownership. Nearly 50% of CO2 emissions in Somerset are from the transport sector and tackling this quickly must be a priority. Increased active travel will help tackle increasing public health issues from inactive lifestyles. Better provision will reduce injuries and deaths to pedestrians and cyclists from road crashes. The petition received 1800 signatures. We'd like to thank Councillor Woodman for his time and the constructive conversation that we had. While we wait for the official response to the petition, we have a number of follow up questions: 1. Will SCC adopt our network plan for future policy? Although there is now a draft Local Cycling and Walking Plan, this only covers a number of routes, rather than a comprehensive network. SWTC have adopted it as a policy document 2. Will SCC appoint a 'Cycling Champion' to spearhead the cycling network work, in the same way that some other authorities and SWTC have? 3. When do SCC envisage that work will be begin on the route improvements outlined in the LCWIP?
