Key priorities

Overall conclusion

- Strengthened their response to children and young people, including providing help and support earlier
- More to be done to ensure that service responses are consistent and effective
- Important to listen and respond more systematically to what children and their families are saying works for them

Serious case review: Fenestra

9 child victims of sexual exploitation

Learning

- need for long-term intervention (including parental support)
- Meeting emotional and mental health needs of young people who have been exploited
- improved information sharing and collaborative responses
- improved community safeguarding e.g. tattoo parlours.

Actions/Impact

- Single agency and multi-agency action plans
- Training and roadshows
- Improvements in agency responses to sexual exploitation
- Improvements in intelligence and increased disruption
- Topaz

Serious case review: child Sam

Life changing injuries to a 6 month old baby

Learning

- assessing and responding to risk within the wider family
- understanding of thresholds and the pre-birth protocol
- improved handovers between staff and improved information sharing
- health-specific findings e.g., training on recognising the presenting signs of brain injury in children.

Actions/Impact

- Development of pre-birth toolkit to identify and respond to risk
- Action plans and awareness raising communications/training
- Thresholds document refreshed
- Improvements seen in agency identification, assessment and response to risk and vulnerability pre-birth

Learning review - suicide

13 child deaths between 2009 and 2017 as a result of suicide or probable suicide

Priority areas for action:

- Multiagency working children and young people's mental health needs
- Identification of self-harm as an indicator of suicide risk
- Recognition of the issue of suicide prevention in the LGBT community
- Information and support for those bereaved or affected by suicide

Priorities 2018/2019

- Early help
- Consistent partnership approaches to safeguard very young children
- Improving identification and effectiveness of responses to neglect
- Promote understanding of contextual and complex safeguarding
- Improved QA, incorporating better understanding of children's lived experiences/child's voice.


Early Help Proposals

Somerset's Agreed Early Help Vision

Early Help is everyone's responsibility; we want children, families, communities and agencies to work together so that families are assisted to help themselves and are supported as soon as a need arises, thereby improving the overall wellbeing and quality of life of all Somerset's children, young people and their families.



Working Together to Improve Health and Wellbeing



Cabinet in September 2018 approved:

- the LGA recommendations to move to **a statutory minimum children's service** to meet the council's financial imperative.
- only funding early help services which directly reduce children's services costs (Safeguarding, SEND & Youth Justice).
 - a significant reduction in spend on Getset through efficiency measures (higher caseloads allowing a reduction in staffing) of £2m.
 - to consult on the future of Getset Level 2 services on the basis that the remaining service is in excess of the statutory minimum for children's services.



Early Help – Statutory Guidance

- Local authorities lead for developing joined-up early help services for children
- The safeguarding partners (LA, Police & CCG (NHS)) should agree with their relevant agencies the levels for the different types of assessment and services to be commissioned and delivered
- All practitioners, including those in universal services and those providing services to adults with children, should understand their role in identifying/addressing needs of children
- Lead practitioner should undertake the assessment, provide help to the child and family, act as an advocate on their behalf and co-ordinate the delivery of support services.
- A GP, family support worker, nurse, teacher, health visitor and/or special educational needs co-ordinator could undertake the lead practitioner role




