M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

All people involved in the supply of alcohol will receive training on the offences under the Licensing Act 2003 and policies in place at the premises such as the age verification policy forms of acceptable ID and when and how to refuse sale

b) The prevention of crime and disorder

The challenge 25 proof of age policy shall be in force at the premises and notice to advise members of the public of this shall be displayed.

c) Public safety

CCTV will be installed and maintained at the premises. Images will be kept for 31 days. Management or supervisory staff will be trained on how to download images and create evidential discs. Images shall be provided to the Police or an authorised officer no later than 48 hours after receiving a valid request.

d) The prevention of public nuisance

A refusals register will be kept. All refused sales will be recorded in it and it will be reviewed weekly by the designated premises supervisor. The refusals register will be made available for inspection to the Police and Authorised Officers.

e) The protection of children from harm

The only forms of ID that shall be accepted at the premises are passports, driving licences, PASS proof of age and Government issued identity card.
