Chris Waddilove	<p>A Cultural Hub for Somerset</p> <p>My name is Chris Waddilove. I have been resident in Taunton for 21 years. I am here this afternoon because I have read the Delivery Plan for your Cultural Strategy and wish to engage with you urgently on this because I believe that access to culture is so important for wellbeing and enlightenment. I was really heartened, as I started to read this document, that the authors felt the same way, making accessibility to the arts the most important criterion for their delivery plan. However there seems to be a fatal contradiction in the plan because a key part of it, as we know, is the development of a 'Flagship Cultural Hub' for the county in Yeovil, based on the regeneration of the Octagon. Now I have lived all these years in Taunton; I love theatre, dance and live music, but never once in all that time have I travelled from Taunton to the Octagon for an event - for the simple reason I have no car and of course cannot get to Yeovil by public transport and back the same evening. It is much easier to get to Bristol or Exeter for an evening out than it is to Yeovil. So this hub which seems to be absorbing all the moneys coming from Government for the arts in Somerset will be of no benefit to me and thousands like me who love the arts and live entertainment, but who do not own a car and do not live in the purlieus of Yeovil. I simply do not understand how it is possible to come up with a cultural strategy for the county that does not recognise that geographically we need 2 cultural hubs (at least) one for east and one for west Somerset. Yeovil, yes, for the east and Taunton for the west.</p> <p><b>Question 1a -</b></p> <p>So, my question to you councillors for the county, is what about Taunton, your county town? Why are we so neglected? Provision for live entertainment in our town is lamentable. The Brewhouse does its best but with a capacity of 350, it is so limited in what it can offer - and the biggest auditorium we have, believe it or not is the Minster which can only seat 500, and has other obvious drawbacks. I am particularly concerned about the lack of live music. If pub bands or tribute bands or small classical or choral works are not your bag, there is nothing at all by way of live music in the town. This is scandalous.</p> <p>When the shops shut, the town becomes a dead zone, even on Fridays and Saturdays. There needs to be an urgent plan for the regeneration of Taunton. This town needs to find a new identity to revive its fortunes - rather than the barely managed decline we have currently. A cultural hub would in many people's opinions be an exciting and realistic plan to bring footfall, economic prosperity and nightlife back to the town. And there is a building right in the centre of the town that could be the epicentre of that cultural hub. I speak of course of the entertainment centre that opened in 1932 as the Gaumont Palace, doubling as both cinema and variety theatre, now Mecca Bingo. It is a magnificent building with a seating capacity of 1200, still in an excellent state of repair, with a gorgeous art-deco interior - which could be brought back, at relatively low cost, as a first rate live music venue and developed as the multi-purpose arts centre and community hub, that we so need. Somerset Council, of course, own this building</p>

	<p>and the Mecca Bingo lease terminates at the end of 2027 - so, anything should be possible. I belong to a community group which has just been registered by the FCA as the Gaumont Palace Cooperative Community Benefit Trust. We are determined that this great building should be secure as a community asset in perpetuity. We would love to begin a dialogue with Council about this. ### **Question 2c** – the New Government in London

What progress is Somerset unity council making working with other Southwest councils and Peninsula Transport Board and Western Gateway Transport Board on looking at a Regional Devolution deal for Transport the Regional economy, planning and Housing, Through the Transport Boards or the Greater southwest and the western Gateway partnership to improve finance for major infrastructure projects in southwest England. Including The Railway network serving Somerset unity council, Banes and North Somerset council and the southwest.

Regional bus and coach Networks Especially as Scottish City link Megabus have withdrawn the Midlands via Cheltenham spa Bristol Bond Street, Weston super mare, bus and coach station Bridgwater Taunton, Wellington Tiverton Barnstaple coach service. Cllr Gwil Wren	<p><b>Cllr John Hunt reading out on his behalf</b></p> <p><b>Management and Administration of Postal Votes</b></p> <p>As you know my wife and I had a holiday booked from 26<sup>th</sup> June to 5<sup>th</sup> July 2024. Despite applying for a Postal Vote on 6<sup>th</sup> June I received nothing other than an acknowledgement before I left the country meaning that my wife and I were unable to cast a vote in this important election.</p> <p>Having made enquiries about this and received responses that I am not sure are adequate I feel it is appropriate to ask questions in the formal setting a Full Council Meeting. In particular I am concerned about the planning and preparedness of Electoral Services, the resources available to deal with a snap election and the steady increase in demand for Postal Votes.</p> <p>My Postal Vote application was received on 6<sup>th</sup> June and processed the same day. Although candidate nominations did not close until 7<sup>th</sup> June, initial Postal Vote details were sent to the printers on 5<sup>th</sup> June. However, I understand that those that arrived after 5<sup>th</sup> June were not despatched to the printers until 24<sup>th</sup> June, 10 days before the election. Apparently, part of the delay was additional checks required by Government as well as high demand.</p>

It is not clear to me why my application was processed on 6<sup>th</sup> June but took almost 3 weeks before they could be sent out. I appreciate the point about printers capacity but surely it is better to process small batches as and when they arrive rather than wait for all to be done? It is notable that the Elections West stock reply to emails says *“When we send your postal vote will depend on when your application was received and successfully processed, so the sooner you apply the better.”*? However, in reality, the date of application makes no difference.

So my questions are:

1. General and other elections are a feature of British life and tend to rely on the same information and basic administrative processes. It was well known that 2024 would bring both Police and CC Elections as well as a General Election. It was also known that Voter ID would be a factor for voters. So when did Somerset Council commence its planning for the General Election, how much work was just picking up existing processes and what new tasks were required by Government for this election?
2. How many Postal Vote applications were received at the 2019 General Election compared to 2024?
3. What was the Postal Vote return rate in 2019 and 2024?
4. Does the Council or Electoral Commission investigate the reasons for non-returns?
5. I understand that the Electoral Services Team comprised of seven officers to manage seven constituencies although the Team also has three long term absentees. Is this felt to be an adequate level of resource given Local Government Reorganisation, Boundary changes, extra Government requirements and the growing popularity of Postal Votes and how does it compare with the resource levels in the previous four Districts?
6. When a snap summer Election was called resulting in record numbers of Postal Vote applications was there a request for increased resources to manage the increased workload with its hard deadline? If not why not?
7. After a Postal Vote application is received what information regarding processing and turn around time is given to applicants to keep them informed of the progress or their application?
