## CPRE Somerset Speaking Notes - SCC Constitution and Governance Committee - 14.2.23

I am Fletcher Robinson, Trustee and Planner for CPRE Somerset.

At the 30 January meeting we urged the committee to drop the proposed shared three minute speaking arrangements for members of the public. This contentious issue risks turning into an 'own goal' for the new Council.

However, the revised draft retains the same arrangements.

The agenda papers contain a helpful Table comparing <u>current</u> public speaking arrangements across five local authorities in Somerset.

According to the Table, <u>Somerset West and Taunton</u> is top of the league for democratic practices with no limit on the number of speakers and each allowed to speak for three minutes.

Next comes <u>Somerset County Council</u>, which allows 30 minutes in total, with three minutes for each speaker.

Then comes <u>SSDC</u>, which allows 15 minutes in total, with 3 minutes for each speaker.

Bringing up the rear are <u>Sedgemoor</u> which allows just one member of the public to speak against, and <u>Mendip</u>, which the Table says has a shared three minute speaking arrangement.

If you look at the Constitution of each of those five authorities, in the case of the first three, the public speaking rules at committee correspond to what is laid down in the Constitution.

But in the case of <u>Sedgemoor</u>, even though its Constitution apparently allows five speakers to speak for three minutes, in practice only one speaker 'against' is allowed at planning committee.

We made a formal complaint to Sedgemoor last year after the second time we were barred from speaking. It turns out that its 2006 Statement of Community Involvement has a sentence limiting speakers 'against' at planning committee to just one, and this is deemed to take precedence over the Constitution.

And in Mendip, the Constitution allows each speaker 3 minutes. But another Constitutional provision allows for different committees to have different rules. The result has been shared speaking times.

In conclusion- please adopt one of the three more democratic speaking arrangements in the County - those of Somerset West and Taunton, or of your own council, or of SSDC.

And please set them out clearly in the new Somerset Council Constitution.
