#### 1. Council Public Meetings

The former regulations that enabled virtual committee meetings ended on 7 May 2021. Since then, all committee meetings need to return to face-to-face meetings. The requirement is for members of the committee and key supporting officers to attend in person, along with some provision for any public speakers. Provision will be made wherever possible for those who do not need to attend in person including the public and press who wish to view the meeting to be able to do so virtually.

#### 5. **Public Question Time**

Members of public wishing to speak or ask a question will need to attend in person or if unable can submit their question or statement in writing for an officer to read out.

After entering the Council building you may be taken to a waiting room before being taken to the meeting for the relevant agenda item to ask your question. After the agenda item has finished you will be asked to leave the meeting for other members of the public to attend to speak on other items.

A slot for Public Question Time is set aside near the beginning of the meeting, after the minutes of the previous meeting have been agreed. However, questions or statements about any matter on the agenda for this meeting may be taken at the time when each matter is considered.

At the Chair's invitation you may ask questions and/or make statements or comments about any matter on the Committee's agenda – providing you have given the required notice. You may also present a petition on any matter within the Committee's remit. The length of public question time will be no more than 30 minutes in total (20 minutes for meetings other than County Council meetings).

You must direct your questions and comments through the Chair. You may not take a direct part in the debate. The Chair will decide when public participation is to finish.

If an item on the agenda is contentious, with many people wishing to attend the meeting, a representative should be nominated to present the views of a group.

An issue will not be deferred just because you cannot be present for the meeting. Remember that the amount of time you speak will be restricted, to three minutes only.

In line with the council's procedural rules, if any member of the public interrupts a meeting the Chair will warn them accordingly.

If that person continues to interrupt or disrupt proceedings the Chair can ask the Democratic Services Officer to remove them as a participant from the meeting.

Provision will be made for anybody who wishes to listen in on the meeting only to follow the meeting online.

#### 6. **Meeting Etiquette for participants**

- Only speak when invited to do so by the Chair.
- Mute your microphone when you are not talking.
- Switch off video if you are not speaking.
- Speak clearly (if you are not using video then please state your name)

- If you're referring to a specific page, mention the page number.
- Switch off your video and microphone after you have spoken.
- There is a facility in Microsoft Teams under the ellipsis button called turn on live captions which provides subtitles on the screen.

#### 7. Exclusion of Press & Public

If when considering an item on the agenda, the Committee may consider it appropriate to pass a resolution under Section 100A (4) Schedule 12A of the Local Government Act 1972 that the press and public be excluded from the meeting on the basis that if they were present during the business to be transacted there would be a likelihood of disclosure of exempt information, as defined under the terms of the Act.

If there are members of the public and press listening to the open part of the meeting, then the Democratic Services Officer will, at the appropriate time, ask Participants to leave the meeting when any exempt or confidential information is about to be discussed.

#### 8. **Recording of meetings**

The Council supports the principles of openness and transparency. It allows filming, recording, and taking photographs at its meetings that are open to the public - providing this is done in a non-disruptive manner. Members of the public may use Facebook and Twitter or other forms of social media to report on proceedings. No filming or recording may take place when the press and public are excluded for that part of the meeting.

4 Scrutiny for Policies, Children and Families Committee Work Programme - Agenda Item 5

The Committee considered and noted the Committee's current work programme and the Executive Forward Plan of planned key decisions in coming months, including Executive meetings.

#### 5 **Education and Inclusion Services Redesign** - Agenda Item 6

The Committee received a PowerPoint presentation from the Council's Assistant Director, Inclusion Dr Rob Hart, who presented the proposals for the Education and Inclusion Services redesign.

Dr Hart covered the following in the presentation – context / aims of the service redesign and the need for systemic change; outlined the current structure and issues and challenges; detailed proposals within an area-based structure, with clearer accountability structure; what kind of service will become; strengthening preventative capacity; outlined the consultation process and proposed timeline with implementation from beginning of 2023.

The Committee had a broad discussion on the proposals, covering – how will know the changes lead to the outcomes wanted (what will 'success' look like); where the proposals sit in terms of national guidance and best practice; where and how early years 'fit' in the proposals; details on the Support Services for Education (SSE), management and commercial development.

The Committee requested that the final proposals be presented to the Committee, after the consultation and engagement had concluded, and prior to approval being made on the redesign by the Executive.

#### 6 Update on budgetary pressures in Children's Services - Agenda Item 7

The Chair advised that unfortunately the Council's Deputy Director Children's Services was unable to attend the meeting. It was noted that the Ofsted Inspection of Children's Services is currently taking place.

As a background to the item, the link to the revenue budget monitoring report had been shared with the Committee. This report had been considered at the Executive meeting on 11 July 2022 and concerns the 2022/23 revenue budget monitoring report – month 2 – end May 2022, and in particular the information relating to Children's Services.

It was noted that the Place Scrutiny Committee considers the budget monitoring reports. However, the Chair had wanted the report to come to this Committee so members could discuss the Children's Services specific sections of the paper as this highlights the issues which are important to the Committee. The Chair said that he would be happy to receive any questions from Committee members and coordinate responses.

The item was DEFERRED to a future meeting.
