## Trial Background


- Rental escooters legalised July 2020
- Support 'green' restart of local travel during the pandemic
- Data capture to inform decision making regarding future legislation
- 31 live Local Authority trials
- Procurement process to appoint an escooter operator
- Zipp manage the SWT scheme in Taunton and Minehead
- Escooters classified as a motor vehicle
- Users must be 16+ with a provisional/full driving licence
- Taunton started October 2020 and Minehead started June 2021
- Trial end date 30 November 2022










Demographics registered users for Minehead


Whilst the minimum legal age to ride an escooter is 16 the number of registered users at that age is very low.

#### The number of rides for those users is also very low.


- 1,609 in Taunton

- Night-time rides were 19,044 which was 26% of all rides





#### Monthly stats from the police

- All calls for all escooter incidents
- Both trial and non-trial
- Wide ranging, majority incidental to the report
- Increase in March/April due to component theft

## Escooter Accident 17/05/22 - Confirmed Detail

- Incident involving a female pedestrian and an escooter
- Just one scooter involved, although there was another youth on foot
- Victim never lost consciousnesses and there was no pool of blood
- Escooter involved was a Zipp scooter
- · Zipp have provided the police with information needed to make an arrest and interview the culprit.
- · Possible due to the requirement for all users to register their driving license when they first sign up
- All rides are tracked using GPS and Geofencing
- Escooters are classified as a motor vehicle, as such they fall under the Road Traffic Act. This
  places the same responsibility on the rider to comply with all Road Traffic Act laws as any car or
  motorcycle user.
- The police have confirmed the rider has been identified, formally interviewed and reported for two
  offences
  - 1. Driving without due care and attention
  - 2. Failing to stop at the scene of an injury collision and failing to report the collision to police.
- · Zipp have reported the accident to their insurers



"It is fortunate in a way that this was a Zipp scooter and not a privately owned one as the chances of identifying the rider would have been slim otherwise."

"I can only praise Zipp (particularly the Taunton branch manager). I was provided with very timely information to the riders identity and GPS data from his scooter, which ultimately left the subject with no choice but to admit his wrongdoing"

## The Future for Escooters

The Queen's Speech, 10 May 2022 announced the Government's intention to introduce legislation on the future of transport as part of a Transport Bill.

#### Aims of the Transport Bill

- Create new regime for regulating micromobility
- Create a new, low-speed, zero-emission vehicle category
- · Establish regulation ensuring safety for users, pedestrians, and other road users
- Implement new rules to include robust technical requirements and a set of requirements for users
- Give powers to local transport authorities to shape and manage rental operations, for pedal cycles, e-cycles, and escooters

#### **Decision Making**

- DfT will consult publicly before any regulations for escooters and the rental schemes are made
- There will be no final decisions until the Transport Bill becomes law

#### **Trial Status**

- Current regulations for rental escooters still apply
- Private escooters remain illegal to use on public roads
- Trials will continue to run until 30 November 2022
- · No decision has been made about what will happen to trials after that date
