- 1. Executive Summary / Purpose of the Report
- 1.1 The Council Procedure Rules within the Council's Constitution require that the following items of business are transacted at the annual meeting of the Council:
  - a) To decide which Committees to establish for the municipal year;
  - b) To decide the size and terms of reference of those Committees;
  - c) To decide the numerical allocation of seats to political groups on Committees in accordance with the political balance rules;
  - d) To make appointments to Committees
- 1.2 At the time of writing this report, two reports are going through the democratic process that would potentially amend the committee make-up, terms of reference, numerical allocation and appointment to Committees. Both reports are due to be considered by Special Full Council on the 29 April 2021 and relate to:
  - a) The Council Governance Arrangements Working Group Report
  - b) Update to the Constitution Report
- 1.3 In light of the above, the recommendations for this report will be split into two options. The first option will make the assumption that there will be no changes from the 2020/2021 Municipal Year. The second option will make the assumption that the two reports going before Council on 29 April 2021 are approved and this will reflect the relevant changes.
- 1.4 The Monitoring Officer will ensure that an update note is published as an addendum to the Annual Council Meeting as soon as is practicable following the Special Council meeting on 29 April 2021.

  - Planning Committee
  - Licensing Committee
- 4.3 At the time of writing this report, a report from the Council Governance Arrangements Working Group is going through the democratic process, and is due to be considered by the Executive on 27 April 2021 and Special Full Council on the 29 April 2021. If the Council resolves to make the changes set out in the report, the Committees for the 2021/2022 Municipal Year would be, (in addition to the Full Council and Executive):
  - Corporate Scrutiny Committee
  - Community Scrutiny Committee
  - Audit and Governance Committee
  - Planning Committee
  - Licensing Committee
  - Standards Committee

## Size and Terms of Reference for those Committees

4.4 The size of the Committee's set out in section 4.2, and as per the current Constitution are:

- 4.8 The numerical allocation of seats to political groups on Committees for Option 1, can be found in Appendix B to this report.
- 4.9 The numerical allocation of seats to political groups on Committees for Option 2 can be found in Appendix E to this report.
- 4.10 In respect of both appendices they are based on 58 Councillors, following the resignation of Cllr Martin Hill. Due to the Coronavirus Regulations ending on 6 May 2021 and the possibility of Councils not being able to continue to hold virtual meetings after this date, we have brought forward the Annual Council Meeting to the 4 May 2021. However, this means it will now take place before the Trull, Pitminster and Corfe by-election being held on 6 May 2021. A further report on the numerical allocation will come back to the next Council meeting setting out the allocation of seats to political groups based on the full complement of 59 Councillors.

- 4.11 The current appointments to Committees can be found in Appendix C to this report.
- 4.12 The schedule for appointments to Committees for Option 2 can be found in Appendix F to this report. Discussions are ongoing with Group Leaders and this can only be completed once the decision of Council on 29 April 2021 is known.
