- 1 Executive Summary / Purpose of the Report
- 1.1 In January 2023, the Committee on Standards in Public Life (CSPL) published their report on Leading in Practice (Appendix A).
- 1.2 Lord Evans, Chair of the CSPL wrote an open letter to Public Sector Leaders asking them to consider how they build ethical values into their ways of working (Appendix B).

- 4.1 In January 2023, the Committee on Standards in Public Life (CSPL) published their report titled '*Leading in Practice*'.
- 4.2 The report focuses on the Nolan Principles in Public Life and ethical values. The CSPL is asking Public Sector Leaders to embed the principles and ethical behaviours into their organisations and culture.
- 4.3 In his introduction, Lord Evans states 'Senior leaders must ensure that values are understood and embedded into all aspects of how their organisations operate from the way leader communicate with employees, to the priority given to developing good decision-making, to the approach taken to recruitment and performance management.

While the tone from the top is critical, leadership matters throughout an organisation. Leaders at all levels have a fundamental role in exemplifying and helping their teams live up to the principles in their day-to-day behaviours'.

4.4 It is recommended that the Chair of the Committee writes to Duncan Sharkey, Somerset County Council (SCC) Chief Executive, Cllr Bill Revans – Leader of SCC, and the Chair of the SCC Standards Committee to ask them to consider this report to ensure that ethical values are embedded into the culture and ways of working for Somerset Unitary Council.
