Max Wide chaired the meeting.

The meeting began by discussing engagement of the LCN and why some parishes might not be getting involved. John Reckless suggested the name of the LCN could be a stumbling block for some as it didn't make them feel like they belonged. He suggested an alternative of East Mendip and Frome. Max agreed that deciding a name for the LCN was required. Dawn Denton felt some people were not sure how they would fit in. Not all their issues were the same so they weren't always sure what they would be getting out of it. Mike Salmon felt there was a lack of clarity of responsibilities of the group going forward. He suggested if those were established there might be more parish involvement. Mike also noted that some parishes may struggle due to not having enough active people on their councils.

Max introduced the agenda for the meeting. He spoke about how the LCN was in a state of transition from being a pilot to a new fully fledged local community network.


#### Engaging with parishes

Max noted the proposal was:

Officers from the new Somerset Council and the LCN chair engage with parishes to find out, given the content of the LCN handbook and FAQ's

- How they think the LCN could best be set up to be appealing and successful
- What the issues are that could form part of an area plan
- Whether they wish to be part of making the case of the devolution of assets and budgets

Max presented a diagram of how a design process could look



He noted that at the moment we were in the first circle. He wanted to work with those at the meeting to design a set of questions to do a comprehensive survey of the parishes. Following the meeting there was a need to have consultation and discussion. The feedback

from the survey would be brought back to the meeting in July with a proposal for moving forward. Max acknowledged that not all parishes were present at the meeting, so it was important to engage outside of the meeting to ensure everyone has the opportunity to have their say and be part of the conversation.

On 16 June a meeting was planned with the Somerset councillors and Somerset Council to discuss reaching a consensus on who might want to be chair or vice chair. Max noted the guidance said a Somerset Cllr should be Chair or Vice Chair. Then other posts were available to those within the network

Mike Salmon raised a concern about the amount of Frome Cllrs who attended the LCN meetings and how it felt Frome dominant and how they might get more votes. Max explained that the terms of reference says Frome will only get one vote. He also explained he wanted to design this process as sometimes perception was not the reality. Lisa Merryweather noted that she saw it as an opportunity for Frome Town Council to work with the surrounding villages and parishes and see how we could all support each other.

Michael Gay requested that the in the future when members of the LCN are being asked to make decisions that the proposals and supporting documents were circulated in advance. There was then an opportunity to speak with their fellow Cllrs and attending the meetings more prepared. Max agreed that that would be the intention going forward when the LCN is properly resourced.

Sara Skirton clarified the terms of reference did need to be observed but not at the detriment to partnerships. The intention was for these meetings to be participative and inclusive. She noted they would not be looking to limit the number of representatives from any particular parish. In terms of support there would be a dedicated LCN Link Officer employed by Somerset Council for each LCN. Each meeting would be supported by a Democratic Services Officer.

Proposed questions Geography and issues

What we don't know....

- Are key relationships disrupted by the geography?
- How do we reach out to the people who are not here?
- Are there any 'communities of interest' that we want to be part of? (Towns and parishes not linked geographically but working on issues of interest to us?)

Anne Hills noted it would be useful to understand the networks and connections those in the LCN had outside of that. A heat map of who's linked to who.

Andy Jones asked if any other parishes would be willing to host these meetings in their own locals. Kate noted that Somerset had purchased some tech to allow hybrid meetings to continue, the only requirement was good wifi. Buckland Dinham, Rode and Wanstrow said they would be willing.

Kate Hellard picked up on the mentions of walking and cycling from other parishes and the opportunity for them to link up particular Wanstrow, Beckington and Bruton.

#### Sponsorship and support

Sara clarified the following:

- There would be a sponsor for each LCN a corporate role to support the priorities and bring partners to the table.
- There would also be an LCN Manager (overall operational responsibility) and nine full time equivalent link Officers these would not be admin roles, more about making things happen. They would support LCNs to come up with priorities, testing them and helping to address them (evidence based). Making sure there is a link back to Somerset Council. Engaging with other partners such as police etc. to help inform their policy development, decision making and strategic planning,
- Communities of interest Link Officers working as a team across Somerset. Think strategically act locally.

#### What we don't know....

- Who will our sponsor be?
- Can we influence them?
- Can we influence who our support staff will be?
- What do we want their role to be?

#### Role and purpose

What we don't know...

- Are there decisions that will be devolved to us
- What should our plan contain?
- What status will we have within SC and with partner agencies, how will our issues be on their agenda?
- What support will we get to identify community priorities?

#### Issues across our area

- Housing and Planning
- Public transport
- Climate and ecological emergency
- Access to Health Services
- Aging population and demographic imbalance
- Increased pressure on Mental Health services
- Lack of employment opportunities
- Lack of higher education opportunities
- Rural facilities for families

- Local food provision and amenities
- · Gritting of roads
- Internet access
- Social cohesion

Max explained his idea was to take the feedback generated at the last meeting, identifying issues, but also ask if there are any others that people think are particularly pertinent to them in their different parishes.

Shane Collins suggested adding decentralising litter collections. Done by local people as opposed to one person from Idverde.

Max explained the idea was to go around the parishes and ask, do these fit for you? Some may say it is nothing to do with us but that is still relevant. It would help us understand the issues, where they exist and who for.

Anita Collier thought it would be useful to understand what stops people being present. Max felt there may be some questions about what would encourage people to come and are there things that they currently find off putting?

Those in the room online had 10 minute discussions about whether these were the right questions and are there any others to be added.

#### Suggestions included:

- Missing links for transport
- Highways use examples from other pilots and whether we can share
- Strength of feeling, top priorities, rank from 1 10
- How can we support the parishes to come to meetings
- More engaging name for the LCN
- Linking with other networks
- Internet connectivity
- Sustainable travel throughout the network
- Fire, police and NHS unifies all the parishes

- Regular report even not being directly involved people could still keep up to date with what's going on
- What is it you think we can do together that people can't do on their own?
- Groups the LCN itself might be able to feed into useful for people from the LCN to go and talk about the priorities in local areas and in particular issues in particular areas.

Max explained his next steps were to incorporate the feedback into the design of engagement. The outcome would be discussed at the next meeting in July.

Emma Plummer thanked FTC for hosting the pilot meetings, FTC staff for their support and Max for his work as Chair.
