Item 5: **Public Question Time**

How do LCNs work in other councils?

It was confirmed that the rolling out of LCNs in other councils, such as Wiltshire, Cornwall and Buckinghamshire have been successful and somerset have built on the learning from their experiences.

A further question was raised regarding Allocated funding for LCN's.

Councillor Keitch explained that in another Council where pots of money, where specifically allocated, the LCN merely became a grant making body. She pointed out that the Somerset LCNs wanted to avoid that and therefore the Council would not be allocating individual pots of money to each LCN at the current time

As LCN identify and develop their priorities there may be a need to identify funding sources to support the delivery of actions however we have seen in the pilots that this funding could come from an array of sources.

She further pointed out that the LCNs were set up by somerset council for each LCN to decide what they needed and have a voice within the council.

Item 6: To determine the priorities and areas of focus for the Local Community Network for the next 12 months

Item 6a: What are LCNs and how will we work together

Kate Hellard (Service Manager LCN) shared a presentation on the purpose of the LCN and how it would feed back into the work of Somerset Council.

The meeting noted there was a dedicated page on the Somerset Council website at <u>Local Community Networks (LCNs)</u> (<u>somerset.gov.uk</u>) and a contact officer could be contacted on <u>lcn@somerset.gov.uk</u>.

Attendees were asked to share what themes, issues and opportunities they wanted the LCN to explore over the next 12 months. The questions they needed to keep in mind whilst doing this were:

What topics are important to our residents?

How do we know?

What data/evidence/information would help?

What could be done to solve/improve topics?

Are there local examples already working?

Who do we need to involve?

Who else could be in the room (partners and stakeholders)?

Item 6b: Discussion - What is important to residents and businesses in our area? An opportunity to raise any local issues or concerns for LCN to consider
