Minutes of the Meeting

PROCEDURE AT THE HEARING

- 1. The Chair will open the Hearing and introduce the Sub-Committee and Officers.
 - They will then ask each Party to introduce themselves.
- 2. The Chair will confirm that if a Party is not present their representation/application will be read and taken into account in reaching the decision.
- 3. The Chair will address any registerable interest arising under the Code of Conduct.
- 4. The Chair will consider any submitted requests from a Party for permission for another person to appear at the Hearing. If necessary, the Sub-Committee will retire to deliberate before making a decision.
- 5. The Chair will confirm that the Hearing will take the form of a round-the-table discussion led by the Sub-Committee in accordance with this procedure. If all Parties present confirm that they have seen and understood the procedure to be followed at the Hearing and agree that they are ready to proceed then the Hearing shall commence.
- 6. The Chair will remind everyone that the purpose of the Hearing should be borne in mind at all times i.e. To enable those with a right to appear, to amplify their written application or representation. It is also to assist the Sub-Committee to gather evidence and understand the relevant issues.

- 7. The Chair will confirm what advance papers have been received and that these have been read.
- 8. The Chair will make clear that all Parties should only address the Sub-Committee in relation to matters they have raised in their application/representation. Any Party wishing to submit late evidence at the Hearing will only be able to do so with the consent of all Parties present and with the consent of the Sub-Committee.
- 9. The Chair will confirm whether all Parties have seen and understood the procedure to be followed and are ready to proceed with the Hearing.
- 10. The Chair will ask the Applicant whether they wish to make any amendments to their application with a view to addressing any issues raised by representations.

11. Order of Oral Presentation

- (a) The Licensing Officer will present their report outlining the details of the application/notice/representations received.
- (b) Any Party may question the Licensing Officer.
- (c) The Members may question the Licensing Officer.
- (d) Responsible Authorities will present their case and call any witnesses.
- (e) Any Party may question the Responsible Authorities and any witnesses.
- (f) Members may question the Responsible Authorities and any witnesses.
- (g) Other Person(s) will present their case in turn and call any witnesses.
- (h) Any Party may question the Other Person(s).
- (i) Members may question the Other Person(s).
- (j) The Applicant/Licence Holder will present their case and call any witnesses.

- (k) Any Party may question the Applicant/Licence Holder and any witnesses.
- (I) Members may question the Applicant/Licence Holder and any witnesses.

The Chair at their discretion, may change the order of oral presentation at any stage, if it is considered to be beneficial to the flow of the hearing.

- 12. Before moving on to the next Party, the Chair will check there are no further points the current Party wishes to make or any further questions that need to be put to that Party.
- 13. The Licensing Officer may present any further information such as proposed nonmandatory Conditions deriving from the Operating Schedule or suggested by any Party. However, it will remain for the Sub-Committee to determine what conditions will apply, if any, should the application be successful.
- 14. Each Party will be invited to make closing submissions in the following order
 - a. Responsible Authorities
 - b. Other Persons
 - c. The Applicant
 - d. Licensing Officer
- 15. The Chair will then close the Hearing and the Sub-Committee will retire to determine the matter. The Legal Advisor will retire with the Sub-Committee to answer any points of law.
- 16. The Sub-Committee will come to a decision which will be sent to the Applicant and all other relevant Parties together with the details of the right to appeal.

Introduction and Background

- 1. The matter for consideration before the Sub-Committee is the determination of an application to specify an individual Designated Premises Supervisor (DPS) in accordance with the Licensing Act 2003, following the receipt of a relevant representation by way of objection on behalf of the Avon & Somerset Police from Police Alcohol Licensing Officer, Nicola Cooper.
- 2. On 13th February 2024, an application to vary the Premises Licence to specify an individual as Designated Premises Supervisor (DPS) in respect of Laburnum House Hotel, 4 Sloway Lane, West Huntspill, TA9 3RJ was received in full, from Mr Steven Cox. The application seeks to vary the licence to specify a new DPS, Mr Steven Cox. Mr Steven Cox is also joint Premises Licence Holder with his father, Mr David Cox. A copy of the redacted application form is shown as **Appendix A**.
- 3. The premises licence authorises the retail sale of alcohol for consumption on and off the premises during the following hours: 11.00 hrs to 00.00 hrs Daily. Prior to the application being made, Mr David Cox was the named DPS. A plan of the premises and maps of the area surrounding the premises are attached as **Appendices B** and **C** respectively.
- 4. On 26th February 2024, Nicola Cooper submitted a representation in respect of this application on behalf of the Police, the representation report being shown as **Appendix D**. The Police have provided further documentation in support of the representation, namely a witness statement (**Appendix E**), a copy of email correspondence between the Police and the applicant (**Appendix F**) and a letter dated 21st February 2024, sent by the Police to the Licence Holders (**Appendix G**).

Recommendations

- 5. The **Licensing Sub-Committee** is required to determine the application in accordance with the Act and must resolve to do one of the following:
 - a. To grant the application to vary the premises licence to specify the DPS as Mr. Steven Cox.
 - b. To refuse the application to vary the premises licence to specify the DPS as Mr. Steven Cox.

Reasons for recommendations

- 6. It is therefore the duty of the Licensing Sub-Committee to determine the application with a view to the promotion of the licensing objectives which are: -
 - The prevention of crime and disorder;
 - Public safety;
 - The prevention of public nuisance; and
 - The protection of children from harm.
- 7. The representation in this case refers to the prevention of crime and disorder.

Other options considered

8. Not applicable.







I am a Police Alcohol Licensing Officer of the Avon and Somerset Constabulary, in whose area the above premises are situated, and I am authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003. An application has been made to vary the premises licence to specify an individual as designated premises supervisor under section 37 of the Licensing Act 2003. I have considered this application and the Police are satisfied that the exceptional circumstances of the case are such that granting the application would undermine the crime prevention objective.

On 9th February 2024 we received an application to vary the Designated Premises Supervisor (DPS) of the above premises to Mr Steven Cox (the applicant), case number FS-585599801. Understand that the consent form was missing and a complete application was subsequently received on the 13th February 2024. The Personal Licence number on the application form states "Can't find it". I have since asked for a photocopy of the Personal Licence but this has not yet been received. To enable the licensing sub-committee to fully consider our representations, I would like to give some background information in respect of the applicant and the premises to date as follows:

The Premises License for this premises is for a Hotel and Restaurant but I have been advised that it has not been run as such for at least 3 years and the licence is not currently suitable for the activities which is long-term accommodation for Bulgarian Nationals. This is in breach of planning legislation and I understand there is an application pending for change of use.

Our representations include recent unauthorised sales of alcohol taking place at the premises outside of the licensed area. Ongoing unauthorised sales of alcohol were found to have been taking place at a premises known as the "Escape Rooms" within the curtilage of the site in November 2023 and despite our advice, further unauthorised sale of alcohol again in January 2024 from a "shop premises" also outside of the licensed area. I attach a letter sent to the Premises License Holders on the 21st February which fully outlines our findings and is self-explanatory. A signed copy of this letter has not yet been returned to us by the Premises Licence holders as requested. We ask that the letter is fully considered as part of our representations.

During a telephone conversation with the applicant on the 21st February 2023 to discuss this application and the premises in general, he has refused to listen to advice and would not allow me to speak. The s.182 Guidance of the Licenaige Act 2003 (Dec 2023) s.4.62 and the Council's

Statement of Licensing Policy 4.5.3. (May 23) states that it is essential Appendix in other Responsible Authorities can immediately identify the DPS so that any problems can be dealt with swiftly. It states that the DPS will occupy a "pivotal position" but I do not feel that the applicant has shown any willingness to work in Partnership with us. I have attached a statement outlining my recollection of the telephone call which we would ask is also considered as part of our representations. I also attach copy correspondence of an email trail which followed between myself and the applicant.

This premises was initially brought to my attention by the Neighbourhood Sergeant PS Hardaway due to concerns with sale of alcohol from a "shop" within the site. I subsequently attended the premises at her request and staff/residents including the applicant have denied that there is any shop premises within the site. At the same time I have met with a tenant of the "Escape Rooms" within the site, who had been advised that he could sell alcohol under the terms of the premises licence but which was not authorised by their licence. The applicant was present during this conversation on 14th November 2023.

It is our expectation that a Designated Premises Supervisor and Personal Licence Holder will be a responsible person in "day to day control" of the premises. Having looked at this premises in detail when collating information for the attached letter, it appears that the applicant has no regard for the law or his responsibilities under the Licensing Act 2003 and associated legislation. Although our representations do not relate to relevant offences or conditions of the licence the information we are putting forward we believe amounts to exceptional concerns whereby we feel we can evidence that the applicant has a general disregard for the law and thus is not a suitable person for the role of DPS.

Regarding associated legislation the s.182 guidance of the 2003 Act point 1.19 states that licensing authorities and licensees should be mindful of requirements and responsibilities placed upon them by other legislation which would include:-

• The Gambling Act 2005 • The Environmental Protection Act 1990 • The Noise Act 1996 • The Clean Neighbourhoods and Environmental Act 2005 • The Regulatory Reform (Fire Safety) Order 2005 • The Health and Safety at Work etc. Act 1974 • The Equality Act 2010 • The Immigration Act 2016 • Regulators' Code under the Legislative and Regulatory Reform Act 2006.

In the vast majority of cases a vary DPS application should be a simple administrative process. However the s.182 Guidance of the Licensing Act 2003 point 4.69 states that "the police may object to the designation of a new DPS where, in exceptional circumstances they believe that the appointment would undermine the crime prevention objective. In summary we re-iterate the following reasons for objecting to this application which we feel meets this criteria as follows:

Unauthorised sales of alcohol despite being advised.
Alcohol on display for sale in unlicensed areas.
Gaming machines in use outside a licensed area breaching the Gambling Act 2005.

Although the lack of fire risk assessments and planning permissions are not relevant to the crime prevention objective for the purpose of these representations, they are relevant to the premises lack of compliance over several years and supports the lack of responsibility and respect for relevant legislation by the applicant. We feel that this background supports our representations that the applicant has a continued disregard for the law and his responsibilities under the Licensing Act 2003.

For the purpose of this representation, we do not believe that the applicant would meet our expectations as DPS and he has denied any responsibility for the offences found, blaming the Police for not advising him yet he has been advised. This only exacerbates the issues. We have also found that the applicant lacks integrity and has proved very difficult to communicate with.

When drafting these representations. I have referred also to Somerset Council's Statement of

Licensing policy and specifically refer to the following points....

Appendix D

- 2.4.4 states that the Licensing Authority expects license holders to ensure that gaming machines in premises licencsed to sell/supply alcohol are made available strictly in accordance with the Gambling Commissions code of practice in alcohol-licensed premises.
- 3.1 Partnership working where delivery includes working with Partner Agencies including the Police.
- 4.5.2. The Premises Licence holder remains responsible for ensuring that the licensing law and conditions are complied with at the premises. Any authorisations should be meaningful and properly managed.

In conclusion, we have considered the Council's Statement of Licensing Policy (May 2023), the Secretary of State's Guidance and current legislation. We have no confidence that the applicant will meet expectations regarding the responsible management of this premises and we do not believe that he is responsible to hold the position of DPS. We have not taken this decision lightly and it is very rare to submit representations that give rise to exceptional concerns.

On behalf of the Chief Officer of Police of Avon & Somerset Constabulary, we believe that the above and attached information does amount to "exceptional circumstances. We are currently collating information for a review of the Premises Licence in its entirety due to the current issues. Although the previous DPS Mr David Cox also appeared to be unaware of the offences and has given me contradicting information about the site in a telephone call on the 8th February 2024, he advised me that he lives on site and is at the premises every day. We are satisfied that to vary the DPS to Mr Steven Cox would not allay our concerns or improve the situation and it would undermine the crime prevention objective.

We ask that the Licensing sub-committee give this matter their attention and consideration.

I am Police Alcohol Licensing Officer 8820 COOPER of the Avon and Somerset Constabulary covering Taunton & West Somerset since October 2012.

On Wednesday 21st February 2022 at 14.59 I received a telephone call from Mr Steven Cox of Laburnum House Hotel, 4 Sloway Lane, Highbridge. He was returning a voice message I had left earlier in the day. I wanted to speak to Mr Cox before sending him a letter dated 21st February 2022 regarding unauthorised sales of alcohol and other licensing issues at the premises. I wanted to discuss the matter by telephone before issuing the letter and discuss the premises licence.

When I answered the telephone Mr Cox was initially polite and I asked why he had submitted an application to vary the Designated Premises Supervisor from his Father Mr David Cox to himself. He said he was more involved in the running of the premises and his father was now elderly. He went on to say that he had just signed a 7 year lease for Hinkley workers to occupy the premises and I stated that he did not have planning permission for that as it had not yet been decided. At that point Mr Cox became verbally aggressive over the telephone towards me calling me a "jobs worth, and that I was rude and he paid my wages". I asked what he meant by that and he said "you must know what I mean by paying your wages and referred to council tax". The call lasted for 15 mins and 51 seconds and Mr Cox would not let me speak. I did not get to discuss the letter or the premises licence.

During the call Steven Cox said it was my job to advise him if he was doing anything wrong. I tried to clarify that he had been a licence holder for over 35 years and he responded "that is for you to find out". He was repeating "listen to yourself, saying something about using my authority, repeating that I was a jobsworth and that he would be making a complaint about me. I asked him what were his grounds for making a complaint. He said there must be an ulterior motive and to just tell him what it was and that I had a personal vendetta towards him and I was rude. He said I had not written the letter and someone else must have written it and to tell him what was going on. At this point he had not been sent the letter or seen it or knew of it's contents. I had only previously met Mr Cox once before and face to face on 14th November 2023 when I had advised him about his licensed area. The letter I was sending to him was putting everything in writing as we must keep a record. He refused to discuss the contents of the letter with me in a civil manner before it was sent to him.

I found Mr Cox to be unprofessional, rude, sarcastic, intimidating towards me. Under s.4.62 of the s.182 guidance of the Licensing Act the Government considers it essential that police officers, fire officers or officers of the licensing authority can identify immediately the DPS so that any problems can be dealt

with swiftly. I did not feel that I would be able to resolve any problems with Mr Cox due to his obstructive attitude.

This is not our expectation for a proposed Designated Premises Supervisor or indeed Premises Licence Holder to speak to a Responsible Authority in this manner. I was so taken aback with Mr Cox's outburst that I put the phone on to loud speaker for colleagues to listen to. They advised me to end the call which I did.

I am happy to discuss this.

The red wine you saw was there against my specific instructions.

I need to explain what you describe as a shop.

For 2 years now I have tried to build a community here.

On Sundays I allow the church to use the conservatory foc.

I provide, FOC, a room for the health visitors, dental, social services, 2 charities and the Bulgarians have over the last 2 years had the use of the room next to the conservatory to sell product to each other.

You may recall the Burger van as well? FOC and in the winter I sponsor hot food on Friday and saturday nights, I have never ever received a penny from these but the goodwill and 'control' of the site is I believe mostly down to these feelgood points that don't really cost me much.

I have never charged for the 'shop'room, it is solely for them, not ever survived long but randomly we see it used.

I have made it clear to the various shopkeepers that no cigarettes or alcohol to be sold.

What surprises me most is that red wine was there, I can only think it was cooking wine because they drink spirits, maybe cheap beer but wine ?

I have explained again that under no circumstances should ANY alcohol be sold.

If I'm correct, I could sell it from the normal bar but I choose not to for the reasons already discussed.

I believe Rees is going to reapply for a license by the escape rooms, if successful I think we might surrender the license as he would be able to serve our future clients. You may recall he said he did not sell to the Bulgarians but he has implied he would be happy to service HPC workers.

I am happy to discuss these points whenever, I really hope we can develop a relationship where we stay compliant and fulfil our responsibilities, as ever I will do my best and any help / advice is very, very gratefully received..

Laburnum has been a successful hotel with alcohol sales for nearly 40 years and we hope to return to those days, we just need help.

I am writing to you as Premises Licence Holders and Designated Premises Supervisor of the above premises.

I refer to my visit to the premises on the 14^{th} November 2023 to inspect the shop premises that was selling alcohol. I had been requested to conduct a visit by Sergeant Hardaway. On arrival my findings were as follows:-

In a reception area adjacent to the premises staff and your Manager Mr Deakcun Britton advised me that there was no shop which I later found out to be untrue and I am told by colleagues that the shop had been selling alcohol for some time.
 It was apparent during my visit and as already advised to me by my colleagues, that the site is not being run as a Hotel as per the licence but as an HMO for Bulgarian Nationals on a long term basis, which I understand also breaches planning regulations.
 I witnessed a Gaming Machine in operation in this reception area at the time of my visit which breaches s.242 of the Gambling Act 2005.
 Mr Stephen Cox took me in to the licensed area on the plan and showed me the old Hotel Bar and reception area and pointed out a function room and swimming pool which were no longer in use and disused. He said the premises had not been used for some time. He also told me that there was no shop. There was no licence displayed and he advised that it had been misplaced. There was no alcohol on display in this area. During our discussion you made me aware of disorder on the premises by the residents and also mentioned children being left unattended, and Gangmasters attending the premises which was concerning. In

approx the last 12 months you have made 7 calls to the police about alleged incidents of crime & disorder occurring on the premises.
Staff had directed me to some portakabins and a café <u>outside of the licensed area</u> known as the "Escape Rooms" which I understand is owned and run by an independent third party. Mr Stephen Cox accompanied me to these premises and the tenant advised me that he sold alcohol to his customers and sometimes gave it away as part of the admission fee to the escape rooms. There was no licence displayed and he did not have a copy. He was unable to provide any authority or consent, which would authorise any sale of alcohol within this area. The Premises licence holders were aware of the sale of alcohol outside of the licensed plan and had allegedly allowed the tenant to pay the license fee, advising him that he could sell alcohol.
Mr Stephen Cox advised me that they had consented to him selling alcohol from that area which falls outside of the license plan and I advised you at that time that any sale of alcohol was unlawful.
It was apparent during this visit, that all persons spoken to were unaware of the law and responsibilities under the Licenisng Act 2003.
You were given advice regarding the licensed area and where alcohol could be sold. During this visit Mr Stephen Cox advised me that he did not want the licence, did not need it and nor did he want the machines and to take them away.
I have subsequently followed this up by email on the 15 TH December 2023 requesting surrender of the premises licence and clarifying the licensed area. To date you have not surrendered the licence as requested and agreed during our visit but mentioned a variation of the licence instead. PC Jones has advised me that you have told her that you will not be surrendering the licence.

The Premises licence as numbered above was issued for a Hotel & Restaurant Premises only and I am aware that the site is not being run as a Hotel. My definition and interpretation of a "Hotel" would be described as "an establishment that provides paid lodging on a short term basis".

On 21st July 2005 Ash Clifford applied on your behalf for the licence to be converted to a Premises Licence and on the application form the premises is described as "Detached Hotel & Restaurant (also open to non-residents). All Licensable activities take place on ground floor of building with guests staying in lodges in grounds". We have not received any variations to this application since 2005. I understand there are 61 lodges and some additional unlicensed caravans. The Hotel within the licensed area has been unused for some time and it was unfurnished during my visit and appeared "derelict". There is a notice dated 12th August 2021 on the hotel website stating that your hotel is closed for holiday bookings until further notice. I am also aware of a current planning application for a change of use and a subsequent objection from Somerset Council strategic housing giving further details about the premises and breach of it's use. Other residents have commented that the premises has not been used as a hotel in over 3 years.

Following my visit my colleague PC Tracey Jones conducted a further visit on the 22nd January 2024 and her findings were as follows:-

➤ Having told me there was no shop, PC Jones was taken to the same shop area that she knew to be trading as a shop. There was a limited stock of alcohol including 10 bottles of red wine selling for £10.00 per bottle and despite my advice regarding the licensed area. This

constitutes continued unauthorised sales or displaying alcohol for sale which is an offence under s.137 of the Licensing Act 2003. A male named Mattios was working in the shop and he had no understanding of licensing law. There was no "due diligence" in place such as staff training. PC Jones was advised that Mattios had set up the shop with Deakcun Britton who had previously advised me that there was no shop. The shop was located next to the reception "service area" which contains the laundry facilities. PC Jones provided me with it's location on a plan.

- ➤ During this visit Mr Britton arrived and advised PC Jones he did not know where the licence was and had told Mattios not to sell alcohol. Mr Britton said he did not tell me about the shop as it was not up and running at that time (14/12/23) which we know to be untrue.
- Mr Britton was advised to move the alcohol into the licensed area but chose to dispose of it. He then poured it down a drain in front of PC Jones.
- Mr Britton advised PC Jones that when Hinkley workers take over they will be running the shop as a Nasa premises but the shop area is outside of the licensed area.
- ➤ I understand there is a second gaming machine in the shop area which would be unlicensed and a further offence under s.242 of the Gambling Act 2005.
- > On a subsequent visit PC Jones has witnessed a supply of alcohol in the old Hotel Bar.
- ➤ On 13th December 2023 and 14th February 2024 you have been advised by Devon & Somerset Fire Service that your Fire Risk Assessment at the premises was deemed not suitable or sufficient.

On 21st February 2024 I have telephoned you to discuss the contents of this letter before sending it to you but you refused to discuss anything with me in a civil manner. You have stated that you are no longer selling alcohol and were unaware of the ongoing alcohol sale/display of alcohol in the shop.

I am also in receipt of an application to vary the Designated Premises Supervisor to yourself but we will be making representations in that respect and referring the decision to the Licensing Authority in view of the offences outlined herein.

As you are aware, unauthorised sale of alcohol is an offence under section 136 of the Licensing Act 2003 and despite being advised, unauthorised sale of alcohol has continued. The maximum penalty under the legislation for responsible persons or management bodies of licensed premises is an unlimited fine &/or six months imprisonment.

It is very apparent during these visits that you and your staff have no regard for the law and your responsibilities under the Licensing Act. In this particular instance the following action will be taken:-

A record of these breaches will be kept on the premises licensing file and may be cited in
any future proceedings.
A copy of this letter has been forwarded to the Licensing Authority at Somerset County
Council.
Further licensing checks will be carried out.
We will not consider any variations to the Premises Licence until the premises is fully
compliant with all relevant legislation including Planning and Fire regulations. The business
use of the premises must be fully clarified so that appropriate conditions can be proposed
