Local Community Networks Core Membership

1. Summary / Background

- 1.1 Following the previous decisions by Council and the Executive, the purpose of this paper is to determine the initial composition of the core membership for the 18 new Local Community Network (LCNs).
- 1.2 The purpose of LCNs, as agreed by the Executive on 18 January 2023 and 27 February 2023, is as follows:

To be the focus for community development, engagement and partnership working at a local level; improving outcomes for residents and establishing strong connections between the Council, our communities and our partners.

- 1.3 Following engagement work in 2022 and 2023 as part of Local Government Reorganisation, LCNs began to meet across Somerset from 9 June 2023. This has provided the opportunity to test their associated arrangements in practice and the learning will inform a full review in due course. However, one matter that has been raised and requires urgent clarification is that of the core membership of LCNs.
- 1.4 The Terms of Reference (ToR) state that only core members of LCNs can vote, and that core membership will comprise the following:

1) The elected Somerset Council Councillors representing the electoral divisions covered by the Local Community Network;

2) A member from each City, Town or Parish Council and Parish Meeting within the area covered by the Local Community Network;

- 3) Representatives from the following groups or organisations:
 - a) Local Neighbourhood policing team;
 - b) Somerset National Health Service
 - c) Devon and Somerset Fire and Rescue Service;
 - d) Education

e) Representatives from Voluntary, Community, Faith and Social Enterprise Organisations

- f) Representatives from Businesses or Trade Groups
- g) Others as may be considered locally important
- 1.6 In terms of approving the actual Core Membership for each LCN, the Terms of Reference state that:

5.2 The Executive Lead Member for Transformation and Human Resources will approve the core membership of each LCN. Each LCN will review their core membership at their first Annual Meeting and then at least annually and make any recommendations for changes to the Executive Lead Member for Transformation and Human Resources. The core membership list will be classed as the voting members of the Local Community Network

- 1.7. LCN meetings commenced in June 2023. Prior to each meeting, work has been undertaken, through engagement with Councillors and partners, to identify organisations, in addition to those specifically named in the ToR, that could form part of the core membership. It should be noted that it is for those organisations to nominate their representatives.
- 1.8 As LCNs are in their infancy, it is recognised that it will take time for the full range of organisations that could form the core membership to be identified and engaged. This membership will need to evolve over time and could well change, to reflect local circumstances and priorities.
- 1.9. However, for LCNs to be able to operate as Area Boards, they do need to elect a chair and vice chair at their inaugural meeting. In order to do this, the initial core membership for each LCN needs to be defined.
- 1.10 Appendix 1 lists the organisations that, in addition to the Somerset Councillors and representation from Town, City and Parish Councils for each LCN area, comprise the current core membership for each inaugural LCN.
- 1.11 Additional stakeholders within the LCN areas are being identified as part of the engagement and development process. It is anticipated that in due course some of these organisations may be put forward to become core members. Such proposals will be considered by the Lead Member for Transformation and Human Resources.

Recommendations

2. 1 That the Executive Lead Member for Transformation and Human Resources agrees:

- i) That, for the purpose of the inaugural meetings of each LCN, the core membership shall be as listed in Appendix 1 to the report.
- ii) That any subsequent additions or proposed changes to this membership will be considered and approved by the Executive Lead Member for Transformation and Human Resources.

Reasons for recommendations

- 3. 1 The reason for this paper is to determine the initial core membership of each LCNs and thus clarity on who is able to vote at the meetings.
- 3.2 This will enable LCNs to function effectively in accordance with their terms of reference.

Other options considered

4.1. One option considered and initially pursued was to review attendance at each LCN meeting to consider whether those present represented organisations that could be considered Core Members, and therefore eligible to vote. However, this does not comply with the ToRs, in as much as it does not provide the Lead Member for Transformation and HR with an adequate opportunity to approve the membership ahead of the meeting.

Links to Council Plan and Medium-Term Financial Plan

5.1 This recommendation has no impact on the MTFP. LCNs are referenced in the Council Plan.

Financial and Risk Implications

- 6.1. This recommendation has no financial risk.
- 6.2 There is the potential for stakeholder dissatisfaction and reputational risk if LCN Core Membership cannot be defined at this early stage This report seeks to mitigate these risks while recognising that LCN Core Membership needs to be flexible and will evolve other time.

7.1. Local Community Networks form part of the Council's governance arrangements, and are constituted as area boards. Their Terms of Reference are included in the Council's Constitution.
