Other persons

An other person for the purposes of the 2003 Act means the following (as per section 13 of the 2003 Act):-

(a) persons who live, or are involved in a business, in the relevant licensing authority's

area

- (b) a body representing persons who live in the relevant licensing authority's area
- (c) a person involved in a business in the relevant licensing authority's area
- (d) a body representing persons involved in such businesses,
- (e) a member of the relevant licensing authority.

Furthermore the 'vicinity' test has also been removed from 'the Act'. It is for the objector to evidence how they would be affected by the presence of the trading of the business in question. The terms vicinity and interested persons are still referred to within the Mendip District Council Statement of Licensing Policy and should be disregarded.

TO PREVENT PUBLIC NUISANCE	The proposed changes to the hours of opening, playing live and recorded music, with the windows open, and to extend the external area where alcohol can be sold to include the entire outside area would be unacceptable in an urban area, let alone in a quiet rural location.
	Additionally, the premises can only be approached along narrow roads, or a single track bridge which, if the application was accepted, would give rise to considerable traffic noise in the hours of darkness.
	Past events of this nature held by previous licencees could be heard over the majority of Rode, at Wolverton and Tellisford, causing considerable annoyance – and loss of sleep.
