- 4. The contents of the Disclosable Pecuniary Interests (sections 1 to 5 of the form) must be published on the Council's website subject to the omission of any Sensitive Interests see note 1 above.



15.3 I understand that failure (without reasonable excuse) to register or disclose any Disclosable Pecuniary Interest in accordance with section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of section 31(4) of the Localism Act 2011, or taking any steps in contravention of section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
