Section 6 of the form relates to Personal Interests.

Note:

- 1. Where you consider that information relating to any of your interests is a 'Sensitive Interest' you need not include that interest provided you have consulted with the Monitoring Officer and they agree that it need not be included. A 'Sensitive Interest' is an interest which could create or is likely to create a serious risk that you or a person connected with you may be subjected to violence or intimidation.*
- 2. Where the interest is no longer a 'Sensitive Interest' you must notify the Monitoring Officer within 28 days of that change.*
- 3. This form gives general guidance, but is not comprehensive. The County Council's Code of Conduct gives precise requirements. The Localism Act and the Regulations named above should be referred to where necessary. Continuation sheets should be used where needed and clearly marked.*
- 4. The contents of the Disclosable Pecuniary Interests (sections 1 to 5 of the form) must be published on the Council's website subject to the omission of any Sensitive Interests – see note 1 above.*
- 5. The contents of section 6 which relate to Personal Interests will be published on the Council's website unless you indicate otherwise in the appropriate place.*

15.2. I recognise that it is a breach of the Council's Code of Conduct to:

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading; and
- (3) fail to give further notices in order to:
 - bring up to date information given in this notice; and
 - declare an interest that I acquire after the date of this notice and have to declare.

and that any breach of the Code of Conduct can be referred to the Council's Monitoring Officer.

15.3 I understand that failure (without reasonable excuse) to register or disclose any Disclosable Pecuniary Interest in accordance with section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of section 31(4) of the Localism Act 2011, or taking any steps in contravention of section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
