Details of the decision:

Academy for Social Care in Bridgwater (Forum)

Corporate Parenting Board

Parrett Internal Drainage Board

To remove Councillor Richard Wilkins from the Board and to offer this seat to Natural England.

Somerset Catchment Partnership

To add this partnership to the Outside Body arrangement and to appoint Councillor Mike Stanton as Chair of the Somerset Rivers Authority Board.

Somerset Rivers Authority Board

To appoint Councillor Claire Sully as a deputy member for Councillor Ros Wyke on the Somerset Rivers Authority Board. And to remove Councillor Heather Shearer.

Somerset Safeguarding Adults Board

To appoint Councillor Sarah Wakefield to the Somerset Safeguarding Adults Board. And to remove Councillor Heather Shearer from it.

Changes to Committee Membership Details of the decision:

Delegated authority also sits with the Monitoring Officer, in consultation with the leaders of the political groups to update Committee Membership. This authority was given at the meeting of full Council on 24 May 2023.

In accordance with this, the Monitoring Officer has made the following changes to Committee Membership:

Audit Committee

To remove Councillor Steve Ashton from the Audit Committee, and leave a vacancy for a Conservative Member.

Harbour Management Advisory Committee

To appoint Councillor Claire Sully to the Harbour Management Advisory Committee. Councillor Sully will join Councillors Andy Hadley, Marcus Kravis, Leigh Redman, Andy Sully and Rosemary Woods

Planning Committee West

To remove Councillor Sarah Wakefield from the Planning Committee West. And to appoint Councillor Habib Farbahi as a Liberal Democrat Member of the Committee. This will leave a vacancy for a Green/Labour/Independent Member.

Planning Committee East

To remove Councillor Heather Shearer as a Substitute Member of the Planning Committee East.

Strategic Planning Committee

To appoint Councillor Mike Murphy as a Substitute Member of the Strategic Planning Committee.

Reasons for proposed decision:

To update the Internal, Partnerships and Outside Body arrangement with necessary changes as identified for Somerset Council. And also, to update the Membership of Committees with necessary changes as identified for Somerset Council.

Alternative options considered and rejected:

Group Leaders have been consulted on the proposals set out in this report and consensus reached to ensure the bodies listed are fully functional and compliant with the bodies' listed, terms of reference.

Not filling the vacancies, where possible, was rejected as an alternative approach.
