Mark Leeman presented the Better Futures/ MEAM scorecard.

The Better Futures / MEAM scorecard showed mixed results, with some achievements and opportunities, but also some challenges and pressures. Capacity / budget pressures are having a big impact. The group agreed to review the scorecard and reassess the targets and indicators based on that which is realistically achievable.

Jonica Walkinshaw asked what is being done to reduce the 'reds' on the scorecard. Mark Leeman said due to the uncertainty across SC, budgeting issues, potential loss of staff and challenging times, some things are on hold, however, there are still lots of 'greens' on the scorecard.

Jan Errington said some things can be picked up through the Homeless Strategy work, but timeframes may be more stretched out. Need to wait and see what the new structures will be, as to who will be working on it. It is all vital work. This can be added to the action plan for the Homelessness Strategy.

ACTION

JE to ensure the review of the Homelessness/Rough Sleeper Strategy embeds the work of Better Futures/MEAM.

There needs to be a review of what can be realistically achieved due to reduced resources/staffing levels. Scorecard to be reviewed.

ML to review 'Better Futures/MEAM Scorecard/dashboards' with respect to focussing on activity that can be realistically achieved.

Creative Solutions Update

Mark Brown gave an update of the Creative Solutions Initiative, which continues to meet twice a month and discuss complex cases of homelessness and rough sleeping. He also referenced the work being done on client journey mapping, cost calculating, and system blocks and barriers.

Attendance has been good, however, it would be beneficial if more housing, housing providers and homeless teams could attend. There is generally good attendance from health, social care and other

c.	<p>HRB Data</p> <p>Dashboard for Q1, Q2 & Q3 plus commentary slides</p> <p> HRB Metrics Q1 to Q3.pdf</p> <p><u>Trends/Issues</u></p> <p>Rupert presented the data on Rough Sleeping and Homelessness for Q3 and noted some discrepancies and anomalies that needed to be clarified with Leisa Kelly.</p> <p><u>Rough Sleeping & Homelessness</u></p> <p>Q3 (Oct – Dec) - lower. New Rough Sleepers have halved between Q2 and Q3.</p>	RW/GB

Highlights

There was a massive increase in 'Rough Sleepers in a single night', but there was no data in Q1 and Q2 which explains the steep upward trend.

Homeless cases have increased, but a lot more approaches are being recorded. Most cases are advice only.

Proportion of successful prevention cases – remained static. This is concerning as we are below the national average, but we might get to see an upward trend.

It was noted that the stats around Rough Sleepers are the opposite of National statistics. The National trend shows an increase but in SC it has reduced.

Action: RW to explore the statistics with Leisa Kelly and resolve any anomalies

New Transform Family View

Gill Bawler (Children's Commissioning Team) showcased the new Transform Family View system, which links information from various sources and creates a 'Golden Record' of a child and their family. Gill also outlined the plans for testing and rolling out the system to different partners and supporting other local authorities with this work.


Gill Bawler and Michael Preston-Shoot to meet separately, to discuss further e.g. particular cases to help improve the system e.g. linking of Children's Social Care and Adult Social Care.

Bernice Cooke (NHS) expressed an interest in the AI and predictive risk aspects and shared information about the work Barnardo's is doing on children's health equity. Gill Bawler agreed to contact Bernice outside of the meeting to discuss further.



Kate Reed and Jan Errington said it would be useful if housing options could also have access to the new Transform system.

d.	<p>Severe Weather Emergency Protocol (SWEP)</p> <p><u>Update</u></p> <p>Jan Errington and Kate Reed explained the severe weather emergency protocol (SWEP) and the costs of providing emergency accommodation for rough sleepers during cold/extreme weather.</p> <p>SWEP accommodation is offered to Rough Sleepers during severe weather. Most are accommodated, but not in every instance e.g. a particular high risk around an individual, and if not, may be able to offer an alternative, e.g. a tent. During hot weather, sun cream and water is offered. During the hot weather those with respiratory issues can be badly affected and a 'common sense' approach is taken to severe weather across Somerset looking at the combination of feels like temperature, wind etc. Also, it was noted that the climate can differ across Somerset, i.e. sometimes one part of Somerset may be colder than another. Decisions are shared. e.	<p>Homeless Reductions Operations Group (HROG)</p> <p>Jonica Walkinshaw provided feedback from the recent HROG meeting. Group asked for a commitment to complete Somerset Domestic Abuse training. It would be beneficial if housing providers could also commit to attending the same Somerset Domestic Abuse training.</p> <p>Citizens Advice Somerset delivered a presentation on the impact of cost of living for Somerset residents. Within the top 5 debt issues was council tax, which is not included in the national top 5 issues. Something to watch moving forward with plans to increase.</p> <p>Vice chair has changed, Mark Brown has been replaced by Alex Stewart (Second Step).</p> <p>The concern on Guardianship properties was raised due to a feeling within the HROG that this is being offered more frequently, in particular within large care homes which have closed down.</p> <p>Some supported housing providers are also RPs. This point needs to be widely recognised. We can have a role in housing delivery in addition to support. RP's providing accommodation for under 18's from 01.04.24 need to be Ofsted registered and providers have gone through this process.</p> <p>Better Futures – data revision. The data plan is ready to go, which JW will send to everyone to read through, after she has met with Mark Brown and Alex Stewart.</p> <p>HRB Housing First review – to begin at the next meeting of HROG (25th April). Dave Baxter to be invited to help lead this work.</p> <p>A letter has been received from the Domestic Abuse Commissioner, asking for localities to respond re budget cuts etc. This needs to be discussed and responded to.</p> <p>JW mentioned that there are concerns around future admin support for HROG.</p>	JW

	<p>Transformation Board approved Inclusion Health funding to provide an both Outreach GP in Sedgemoor and develop the Homeless and Rough Sleeper nursing service. Not only is this an operational offer we are also required to evaluate the entire GP and Nursing offer with a view to finalising a secure long term NHS Somerset 'service' from April 2025. That data and evaluation work is ongoing.</p> <p>- Last week we finally secured commitment from a PCN with experience in this work already we will finalise the tailored North/Sedgemoor spec and we plan to go to advert for the GP post in April – I hope that our work with key PCN's across the county will be the next part of the media story to keep this on news agendas.</p>
